



## **Crown Dental Plan Membership Agreement--*Terms and Conditions***

Crown Dental Plan Membership Agreement--*Terms and Conditions* for all plan types: Plan A or Plan 1: Individual Member, Plan B or Plan 2: Two Family Members, Plan C or Plan 3: Family Membership; Beginning on the effective date of enrollment for Plan A: "Member," Plan B: "Member and Enrollee," Plan C: "Member and Enrollee(s)," individually and collectively (hereinafter referred to as "Member" and/or "Member(s)") understand that Crown Dental Plan Membership forms an agreement between Crown Dental Plan (hereinafter also referred to as "The Company") and each Plan Member for the period of twelve (12) consecutive calendar months. Members are bound by the *Terms and Conditions* of Membership during the annual period stated, and each Member accepts that Membership is nontransferable to any other person or family member, and Members do agree that once Membership transaction is processed, Membership fee is nonrefundable.

Crown Dental Plan Membership agreement shall not constitute a plan of insurance or indemnification. Crown Dental Plan is not responsible for any payment(s) to Member Provider Dentist or Specialist for dental services rendered, nor is Crown Dental Plan responsible for any Member payment due or balance owed to any financial institution or other third-party service provider, or credit card service provider(s), CareCredit,<sup>®</sup> payment(s) or balance(s) remaining; Members understand the cost of Provider procedures in relationship to Crown Dental Plan Membership discount per procedure, and Members accept full financial responsibility for any costs incurred and payments due from any dental services and procedures rendered by each Provider.

Crown Dental Plan is a privately held limited liability (LLC), not an employee or an agent for any dental Provider, therefore, under material condition of this Membership agreement, Members do hereby agree to knowingly and voluntarily waive all rights, claims, causes of actions of any kind against Crown Dental Plan, The Company Associate(s), The Company Representative(s), and Members do expressly agree to release and discharge Crown Dental Plan from any and all liability, damages, compensation, or otherwise, brought by Members or by anyone on their behalf, and to hold harmless against any and all claims, suits, or actions of any kind whatsoever, caused in whole or in part by Crown Dental Plan, The Company Associate(s), The Company Representative(s), Crown Dental Plan Provider, Provider dental service(s) and/or procedure(s), Provider Associate(s), Provider Representative(s), whether Provider Dentist or Specialist was referred under the Plan or otherwise.

Crown Dental Plan shall have the right to change Member Provider Dentist should Provider discontinue their agreement with The Company, and/or have the option to terminate the agreement at any time if Provider cannot maintain contract obligation under the Provider service agreement. In the event of such termination, any Membership fee paid by Member shall be returned pro rata to cardholder Member. Crown Dental Plan may terminate this agreement at any time if unable to provide the services intended or in order to comply with government regulations regarding dental plans. Members understand that in order to determine the most appropriate oral treatment plan, dental Provider may require an initial office exam and x-rays. Members also acknowledge that Crown Dental Plan Fee Schedule, which enumerates the American Dental Association's Dentist and Specialist procedures by code and Crown Dental Plan Member and Non-Member price per procedure, is subject to change without notice.

Crown Dental Plan Membership Enrollment Agreement--*Terms and Conditions* for all plan types: Plan A: Individual Member, Plan B: Two Family Members, Plan C: Family Membership, constitute the mutually binding agreement between Crown Dental Plan (The Company) and Crown Dental Plan Member(s)/Enrollee(s) ("Member" and/or "Member(s)"); have read and do understand the *Terms and Conditions* of enrollment, and hereby agree, accept, comply with, and are subject to and bound by the *Terms and Conditions* set forth herein, the Crown Dental Plan Membership Agreement.

According to Plan Membership type, cardholder Member signature represents and warrants that whomsoever provides the signature has full and complete authority to bind oneself and other dental Plan Member(s)/Enrollee(s) ("Member" and/or "Member(s)") on behalf of whom he/she is signing, to each and every aspect of the *Terms and Conditions* of annual Membership in the Crown Dental Plan, which begins on the effective date of enrollment for each Crown Dental Plan type.
